**THE IMMIGRATION AND PASSPORT (CYPRUS, CZECH REPUBLIC, ESTONIA, LATVIA, LITHUANIA AND SLOVAKIA) (VISA EXEMPTION) ORDER, 2008 MADE BY THE MINISTER, IN EXERCISE OF THE POWERS CONFERRED UPON HIM UNDER SECTION 15(2) OF THE IMMIGRATION AND PASSPORT ACT, CAP, 208.**

**1. Short title**

This Order may be cited as the Immigration and Passport (Cyprus, Czech Republic, Estonia, Latvia, Lithuania and Slovakia) (Visa Exemption) Order, 2008.

**2. Visa Exemption**

The citizens of the countries specified in the Schedule hereto, landing in Antigua and Barbuda and in possession of a valid passport issued to them by the proper authority of the respective countries are exempt from the provisions of section 15(1)(c) of the Immigration and Passport Act, requiring passports of aliens to be visaed by the consular officer in the service of Antigua and Barbuda or other person so authorised, provided that such citizens do not remain in Antigua and Barbuda for more than ninety days.
